
UPDATES ON ACTIVITIES

ACB Commemorates African Anti-Corruption Day at Various Locations

On 11th July 2023, the Anti-Corruption Bureau (ACB), joined the rest of the African countries in commemorating the African Anti-Corruption Day under the theme "AUCPCC, 20 Years After; Achievements and Prospects".

The ACB conducted activities to commemorate the day and raise awareness on the evils of corruption. The Activities were conducted at regional level; Neno in Southern Region, Songani in Eastern Region, and Msundwe in Central Region. The activities included public forums and football bonanzas during which other activities such as poems, comedies, and dancing competitions were carried out. Winners went away with cash prizes and ACB branded materials.

In Mzuzu, a community engagement meeting was held in Mzimba at Kakholi school ground at Jenda.



Commencement of The Development Of Legislation for The Protection of Whistle-Blowers Programme

The Bureau managed to source funding to start the process of development of the Legislation on the Protection of whistle-blowers. On 20th July 2023 the Special Law Commission on the Development of Legislation on the Protection of Whistle-blowers commenced its work.

When developed, the law will provide for the statutory protection of whistle-blowers against reprisals and other forms of retribution that prevent potential whistle-blowers from disclosing illegal acts or other forms of misconduct that are committed by individuals or institutions within the public and private sectors in a safe and reliable manner.

ACB Signs MoU with ROSAF

ACB signed a Memorandum of Understanding (MoU) with the Roads Safety Alliance Foundation (ROSAF) on 24th July. The MoU will help raise awareness on the dangers of corrupt practices in the road transport sector.

ACB Aids Parliament IIC

The ACB provided technical support to the Institutional Integrity Committee of Parliament to finalise review of Parliament Fraud and Corruption Prevention Policy. The Policy will ensure increased internal controls and strengthen corruption reporting mechanisms at Parliament.

Asset Recovery

The Bureau continues its efforts pursuing asset recovery alongside law enforcement. Apart from cash, the Bureau also recovered a Mercedez Benz within the month of July. In the same month the Bureau removed from Malawi Police premises the remaining vehicles that were forfeited to Government and had been Area 30 Police at Headquarters premises for a very time. The Bureau is processing the vehicles for due disposal.
